

STIX Diabetes Programs Volunteer Releases

Transportation Release

Permission is given to STIX Diabetes Programs to transport me to and from camp activities sponsored by the camp and/or to a medical facility for emergency care.

Media Release

Permission is given to STIX Diabetes Programs to use appropriate images of me in any photos or videos that will be approved by the STIX Diabetes Programs Board of Directors to be displayed in promotional and entertainment media which is created to benefit the work of STIX Diabetes Programs. I understand that there will be no compensation made in exchange for use of any photos or videos as outlined above.

Medical Release

As a volunteer staff member, you are:

- Required to state all medications and all known medical conditions on your physician's release, to be signed by your primary healthcare provider no earlier than 6 months from the first day of camp.
- Required to inform the Camp Medical Director on the first day of camp if your medical condition has changed in any way following the date of your physician release.
- Responsible for your own medication management and for the treatment of any pre-existing medical condition, injury or illness while you are at camp. Exceptions would include junior counseling or counseling program staff who are under the care of the Camp Medical Team.
- Required to inform the Camp Medical Director immediately if your pre-existing medical condition, injury or illness prevents you from performing your volunteer staff duties. Responsible and financially liable for the cost of any third party emergency medical treatment and/or transportation (ambulance, air ambulance, etc.) when requested by you to treat any pre-existing condition, injury or illness.
- Responsible and financially liable for the cost of any third party emergency medical treatment and/or transportation (ambulance, air ambulance, etc.) when requested by the Camp Medical Director or his or her delegate, when in the sole discretion of the Camp Medical Director or his or her delegate, said third party emergency medical treatment and/or transportation is medically necessary to treat your pre-existing medical condition, injury or illness. You will remain liable for any third party expense(s) incurred, whether or not you refuse the third party emergency medical treatment and/or emergency transportation, and/or whether or not you refuse the medical recommendations of the Camp Medical Director, his or her delegate, or medical staff.

• Strongly encouraged to consider a MedStar membership if you have any pre-existing medical condition, injury or illness that could necessitate emergency medical treatment and/or transportation while at camp. This is due to the distance from a nearby hospital trauma center.

Minor Volunteers

Volunteers who are under the age of 18 must be under the care and supervision of their parent or legal guardian while at camp. Their parent/legal guardian must also be a volunteer at camp during the same dates and times that the minor is volunteering. The minor volunteer and their parent/legal guardian are responsible for the minor's medication management and for the treatment of any pre-existing medical condition, injury or illness while the minor is at camp. Exceptions would include junior counseling or counseling program staff who are under the care of the Camp Medical Team.

If you do not fall under these exceptions and your parent will not be attending camp with you, they must fill out the Minor Volunteer Guardian Authorization Form to authorize another adult to act as your guardian while at camp. Without this form you will not be eligible to volunteer.

Volunteers who are under the age of 18 must have the written permission of their parent/legal guardian to volunteer.
